Biographical Sketch

The Cuneo family is best known for the wealth, commercial enterprises, and philanthropic endeavors of John F. Cuneo, the founder of The Cuneo Press and original owner of The Cuneo Mansion and Gardens in Libertyville, Illinois, from whence the papers in this collection originate. John F. Cuneo started his career as an owner of a book bindery but acquired his wealth through large scale purchasing and management of printing press operations across the United States. Cuneo convinced William Randolph Hearst and others in the publishing business to contract the printing and distribution of their publications under long term contracts with specific presses rather than through small, privately owned presses that took on innumerable printing jobs. Such practices required presses to recalibrate their machines and manufacturing processes every time they changed printing tasks. The process Cuneo suggested made way for streamlined production of weekly and monthly publications, creating efficiency in manufacture which pleased both publishers because of reliable and timely distribution, and presses because of reduced manufacturing costs. Cuneo also convinced publishers that the most centralized location for production and distribution was Chicago, which helped bring many of his publishing contracts to Chicago. Cuneo's expanded his venture by purchasing a number of presses across the United States, and he began to pursue economic interests in real estate and other enterprises as well. In addition, Cuneo maintained a philanthropic organization, The Cuneo Foundation, to raise money and give aid to charity. As devout Catholics, the Cuneo family was particularly devoted to

Catholic organizations, for which reason Cuneo contributed funds to various Catholic charities and to Loyola University for many years.

John F. Cuneo was first married to Florence B. Hill in 1905, whom he later divorced in 1917. His second marriage was to Julia Shepherd Cuneo in 1930, with whom he had two children, John Jr. and Consuela. Cuneo's father, Frank Cuneo, was an esteemed Chicago businessman and president of Garibaldi and Cuneo, a produce firm, as well as an investor in Chicago real estate. Cuneo also had a brother, Americo Cuneo, whose estate papers are included in this collection. Their family's history in America is traced back to Cuneo's grandfather, John B. Cuneo, who came to the United States from Italy and started the family business as a local Chicago grocer.

The Cuneo Mansion in Libertyville, Illinois, formerly the estate of Samuel Insull, was purchased and refurbished by Cuneo in 1937. The mansion served as the family estate; it and the other extensive properties owned by Cuneo in the northwest suburbs served as sites where Cuneo dabbled in equestrian and agrarian interests. Cuneo eventually came to found Hawthorn Mellody Farms and Hawthorn Mellody Farms Dairy, where he raised cows, hogs, ponies, horses, poultry, and distributed dairy products. Ever the entrepreneur, Cuneo turned the farm and dairy into a tourist attraction complete with a zoo, where children and families could watch cows being milked, view and pet animals, and see firsthand what day to day agricultural processes were like. The dairy was reported to distribute 400,000 pounds of milk daily to the Chicagoland area. Towards the end of the late 1960s and early 1970s, as John Cuneo aged, parcels of the land were sold off, as well as the dairy operations. The estate, which was bequeathed to Cuneo's son, John Jr., was donated to Loyola University Chicago in December 2009. John Cuneo Sr. had indicated in his will that after the death of his wife, Julia, he wished for the mansion to be used for educational purposes.

Scope and Content

The Cuneo Financial Papers consists of 17 linear feet and span the years 1914-1991. It consists of both the family's personal financial records and the records of Mr. Cuneo's extensive corporate interests. It is divided into personal financial and business financial categories.

Included in the family's personal financial papers are Mr. and Mrs. Cuneo's personal income tax returns, John Jr. and Consuela Cuneo's (the children's) income tax returns, fiduciary income tax returns from the trusts of John Jr. and Consuela Cuneo, records of SEC transactions, the estate papers of relatives Americo Cuneo and Josephine Shepherd, bank statements, checks, notes, and correspondence. The series is organized first by individual and then chronologically.

The correspondence series is arranged chronologically and then alphabetically. Subjects covered are related to both the family financial and the business financial series. The majority of the papers in the series are arranged under the folder titles as designated by Mr. Cuneo or whomever he appointed to maintain his files. Subjects covered in the correspondence series include family and business taxes, farm and dairy operations and maintenance, pony and horse purchases, travel arrangements, corporate operations, and donations to charity.

The business financial papers in the collection are organized alphabetically by business names. It is important to note that Mr. Cuneo owned and oversaw an indefinite amount of businesses during the course of his lifetime; it was a common practice of his to

purchase a company and retain the original business name of that company. Thus, while it has been determined that Mr. Cuneo oversaw his businesses from the vantage point of The Cuneo Press and its various subsidiaries, it has not been fully determined at this time in what way each of the businesses were affiliated and subsequently managed. Included in the business financial series are corporate tax returns, invoices, payment stubs, balance sheets, ledgers, financial statements, accountants' reports, IRS reports, judicial findings, notes, newspaper clippings, and correspondence.

Series 1: Cuneo Family Financial Papers, 1914-1977, Boxes 1-12

Contains materials relating to the income, finances, and taxes of the Cuneo family. It includes the tax returns of John F. and Julia S. Cuneo, John Jr. and Consuela Cuneo, SEC transaction records, statements of financial assets, balance sheets, bank statements, and correspondence pertaining to the Cuneo family finances.

<u>John F. Cuneo and Julia S. Cuneo Income Taxes, 1914-1949, Boxes 1-3</u> Contains income tax returns for John F. Cuneo, years 1914-1949, and Julia S. Cuneo, 1914-1948.

John F. Cuneo and Julia S. Cuneo Financial Papers, 1914-1972, no date, Boxes 3-6 Contains financial papers such as balance sheets, statements of assets, checks, bank statements, IRS documents, and correspondence with lawyers and accountants.

John F. Cuneo SEC Transactions, 1951-1975, Boxes 6-7 Contains securities transaction statements.

Consuela Cuneo and John F. Cuneo Jr. Income Taxes, 1935-1966, Box 8
Contains income tax returns for Consuela Cuneo and John F. Cuneo Jr., years 1935-1966.
The last name changes on several of Consuela Cuneo's tax returns reflect Consuela Cuneo's changes in marital status.

<u>Consuela Cuneo and John F. Cuneo Jr. Income Trust Tax Returns, 1935-1966, Box 9</u> Contains the fiduciary income tax returns of Consuela and John F. Cuneo Jr from the years 1935-1966. As there were several trusts, the returns are arranged by the year each trust was opened, and then chronologically.

<u>Consuela Cuneo and John F. Cuneo Jr. Financial Papers, 1935-1977, Boxes 9-10</u> Contains financial papers such as balance sheets, statements of assets, IRS documents, and correspondence.

Americo F. Cuneo Financial Papers, 1922-1972, Box 11

Contains financial papers pertaining to John F. Cuneo's brother, Americo F. Cuneo, such as statements of assets, real estate appraisals, and estate papers.

Frank Cuneo Financial Papers, 1942-1947, Box 11

Contains the fiduciary income tax returns of Frank Cuneo, son of Americo F. Cuneo, for the years 1942-1947.

Josephine Shepherd Financial Papers, 1926-1974, no date, Box 12

Contains income taxes, reports on financial assets, and the estate papers of Josephine Shepherd, sister of Julia S. Cuneo.

Frank Cuneo Memorial Hospital Benefit Papers, 1965-1977, Box 12

Contains correspondence, invitations, and programs pertaining to annual benefits hosted by the Frank Cuneo Memorial Hospital (named for John Sr. and Americo Cuneo's father). The benefits were sponsored largely by the Cuneo family and The Cuneo Foundation.

Series 2: Correspondence, 1936-1974, Boxes 13-17

Contains correspondence between John F. Cuneo and others, or the saved correspondence of individuals in the employ of John F. Cuneo from his various corporate entities and his estate.

Series 3: Business Financial Papers, 1925-1990, Boxes 18-41

Contains variety of financial records, such as tax returns, balance sheets, sales reports, and ledgers, pertaining to John F. Cuneo's many business ventures, from the years 1925-1990.

American Processing and Sales, 1943-1967, Box 18-19

Contains corporate tax returns, balance sheets, sales reports, IRS forms, sales memoranda, records of securities transactions, sales ledgers, court briefs, and correspondence.

Babcock Printing Press, 1935-1957, Box 19

Contains corporate tax returns, balance sheets, correspondence, Photostats of financial figures, and the title and lien of the acquisition of another printing company, The Robed Co.

Better Speech Institute of America, 1956-1959, Box 19

Contains an auditors report covering years 1956-1959.

Book Productions Industries, 1944-1974, no date, Box 20-21

Contains reports on examination, an IRS report, balance sheets, financial statements, audit reports, lease and deed agreements, a report on audit years, and tax court briefs.

Business Realty Company, 1946-1966, Box 22

Contains corporate tax returns.

Consolidated Book Publishers, 1937-1965, Box 22

Contains fiduciary tax returns on the Consolidated Book Publishers Income Trust, formed 1933, balance sheets, corporate tax returns, and correspondence on research for *Golden Home and High School Encyclopedia*, published by Consolidated Book Publishers.

Cook County Realty Centers, 1956-1963, Box 22

Contains corporate income tax returns.

Cook County Real Estate Papers, 1966-1976, Boxes 23-24

Contains tax bills, payment stubs, and correspondence regarding taxes on properties held by John F. Cuneo in Cook County, Illinois.

Cuneo Eastern Press, 1927-1941, no date, Box 24

Contains copyright, assignment, correspondence, and checks pertaining to the Cuneo Eastern Press publication, "Thrilling Tales"; also contains correspondence and ledgers, a corporate emergency call list, a shipping report for *Life Magazine*, and monthly magazine order cost tracers for *Butterick*, *Fortune Magazine*, *Screen Land*, *Silver Screen*, *American Legion*, *Harpers Bazaar*, *Good Housekeeping*, *Home and Field*, *and Fat Cat*.

The Cuneo Foundation, 1945-1991, Boxes 24-25

Contains balance sheets, income tax returns, treasury department correspondence, Cuneo Museum purchase orders and a fact sheet on the architectural and cultural history of the Cuneo Museum and Gardens.

The Cuneo Press, 1925-1970, Boxes 25-27

Contains corporate income tax returns, Cook County property taxes, proxy statements, Securities and Exchange Commission reports, annual reports, stock information, a report on salaried commissions in 1945, a bill of sale, Screenland Magazine financial reports, a copy of "The Anderson Chronicle," and correspondence.

Byrne to Mr. Cuneo. Also included are records of a horse and carriage auction hosted by the farm, turkey sales and gift lists, silo brochures, horse brochures, and records of participation in an immunization project. There is also a great deal of correspondence pertaining to: ad placements, Lake County (site of property), farm management, horse purchases, the building of the "Log Haven" project or other farm components, and applications for truck travel permits through various states.

Contains corporate income tax returns, IRS claims, deeds, envelopes, a bill of sale, a schedule of real estate, papers pertaining to the liquidation of the company, and a statement of assets on transfer.

Contains corporate income tax returns, appraisal reports, ledgers, blueprints, a pro forma balance sheet, a certificate of registration, rental lists, tally cards, a Milwaukee Golf Shopping Center Economic Analysis report, utility stubs, a property analysis, and papers pertaining to the sale of Milwaukee Golf to Sears Roebuck.
