

Scholarship for the Chief Health and Wellness Officer Act

¹Whereas, According to Chapter 3, Article 10, Subsection 8B of The Articles of Governance, hereafter referred to as the Articles, of The Student Government of Loyola Chicago, hereafter referred to as SGLC, the mission of the Governance Committee is as follows:

“The Governance Committee shall be concerned with evaluating the effectiveness and correctness of the Articles of Governance, and shall draft amendments as necessary in order to maintain consistency, accuracy, and clarity throughout the Articles of Governance¹,”

³Whereas, The Chief Health and Wellness Officer, hereafter referred to as the CHWO, is responsible for a multitude of tasks including serving as advisor to the Safety & Wellness Committee, addressing the health and wellness of the undergraduate student body, acting as a liaison in support of eight types of wellness, meeting regularly with the Director of the Wellness Center, advising the President on health and wellness policy, and completing any further duties concerning health and wellness as assigned by the President¹, and

⁴Whereas, CHWO Raheyima Siddiqui reported an average of 27 hours worked per month concerning CHWO affairs for fiscal year 2020 and an increase to an average of 34 hours worked per month for fiscal year 2021², and

⁵Whereas, 34 hours worked per month results in 8.5 hours per week, more than 3 times the requirement of a 3-credit course, and

⁶Whereas, The position of CHWO was not provided a scholarship for fiscal year 2021, measured as approximately 810 hours of work.

¹Be It Enacted, The Governance Committee recommends Chapter 26, Article 2 of the Articles be amended to include CHWO in the limited positions to which the Scholarship Fund is apportioned, written as follows:

§2. Composition: The Scholarship Fund shall be apportioned across several individual scholarships, which shall be limited to the following:

- (A) The President*
- (B) The Vice President*
- (C) The Speaker*
- (D) The Chief Justice*
- (E) The Academic Affairs Committee Chairperson*
- (F) The Allocations Committee Chairperson*
- (G) The Facilities and Transportation Committee Chairperson*
- (H) The Justice Committee Chairperson*
- (I) The Residents, Commuters, and Dining Committee Chairperson*
- (J) The Safety and Wellness Committee Chairperson*
- (K) The Chief of Staff*
- (L) The Chief Communications Officer*
- (M) The Associate Communications Officers*
- (N) The Chief Financial Officer*
- (O) The Chief Sustainability Officer*
- (P) The Attorney General*
- (Q) The Chief Operations Officer*
- (R) The Chief Equity, Diversity and Inclusion Officer*
- (S) The Associate Equity, Diversity and Inclusion Officer*
- (T) The Chief Health and Wellness Officer*

²Be It Enacted, The position of CHWO shall be apportioned the same scholarship amount as the position of Chief Equity, Diversity and Inclusion Officer for Fiscal
